Even if such a replacement is named, Defendant Jong Sik Chi (also) remains responsible for any and all violations as long as he retains any interest, derives any proceeds, or otherwise has any authority whatsoever over the operation of the market in question, or any other food facility in Orange County, whether controlled by A.R. Supermarket.Inc. or any entity or individual related thereto.
 - b. Likewise, Defendant Bruce Song acknowledges his current (continuing) role as a manager for market operations on behalf of A.R. Supermarket, Inc. so as to be hereafter personally responsible for its adherence to the above conditions. Before relinquishing, transferring, selling, substituting, appointing, or otherwise delegating such responsibilities to any other person, written notice shall be provided and consent obtained from the District Attorney with a named successor to replace him as manager, provided said individual is not a Defendant hereto, related to any Defendant hereto, has completed the approved food safety and handling certification course referenced above, and acknowledges in writing that he or she shall thereafter be personally responsible on behalf of the Corporation for the daily operations as well as any and all (future) health violations at the subject market.
