Originating Department: CITY MANAGER Subject: MAYOR SELECTION PROCESS

PURPOSE

To clarify the City Council's policy regarding rotation of the Mayor among Council members.

BACKGROUND

While each Council member is elected directly by the voters, the Mayor is not; instead, he/she is selected by his/her peers on the Council. The office of Mayor is largely ceremonial, although he/she does have a few additional responsibilities, such as working with the City Manager to set Council agendas and running Council meetings. This administrative policy clarifies Council direction on how the Mayor is selected.

POLICY⁻

Selection of the Mayor by the Council is based on seniority according to the number of years he/she has served on the Council without being selected for the position. In the event a Council member who is scheduled to be the next Mayor chooses not to serve, he/she will move down to "second position," and the next most senior individual will move up to "first position," and thereby have the opportunity to serve as Mayor. Should two or more Council members be elected during the same municipal election, the individual who receives the highest number of votes will precede the Council member(s) who receives fewer votes on the Mayor rotation list.
