**OPENING COMMENTS**

**FC00 - OPENING COMMENT**

This visit is initiated by a complaint (#CO0040497) alleging that a cockroach was found on a wall by the eating area.

On this unannounced inspection, evidence of live cockroach infestation was found.

**IMMEDIATE HEALTH PERMIT SUSPENSION AND CLOSURE**

The permit to operate the above named food facility is hereby temporarily suspended, and the facility is ordered immediately closed under the authority of Section 114409 of Division 104, Part 7, Chapter 13, Article 3 of the California Health and Safety Code. The attached Inspection Report specifies the conditions that warrant this closure and the Sections of the law that are being violated.

Any food facility for which the permit has been temporarily suspended shall close and remain closed until all conditions warranting the closure are corrected and your permit has been reinstated by a representative of Environmental Health.

You are hereby notified that you have the right to request a hearing, within 15 calendar days after service of this Notice to show cause why the permit suspension is not warranted. Your failure to request a hearing within 15 calendar days shall be deemed a waiver of your right to a hearing.

An owner, manager or operator who fails to comply with this Closure Notice may be found guilty of a misdemeanor, with a possible fine of \$1,000.00 and/or imprisonment for not more than six months for each offense.

This Health Permit Suspension and Closure Notice is issued to you under the authority of the California Health and Safety Code, Division 104, Part 7, Chapter 13, Article 3. Copies of the Code Sections referred to herein may be reviewed at most public libraries, the Internet, or at Environmental Health.

**MAJOR VIOLATIONS**

**FC19 - Cockroach Infestation/Activity in Critical Area (CA Retail Food Code 114259)**

Live cockroaches and spotting were observed in the open dry storage room proximal to the kitchen and in the lower coffee station cabinet in the dining room. Spotting were observed in the following areas:

- Coffee Station Cabinet: in crevices between middle door hinges
- In the Kitchen Dry Storage Room: in spaces and holes of the shelf support joint strips on the wall

Eliminate the infestation/activity of cockroaches from the food facility by using only approved methods. Remove all evidence of the infestation and thoroughly clean and sanitize all affected surfaces. Construct, equip, maintain and operate the food facility so as to prevent the entrance and harborage of animals, birds and vermin including, but not limited to, rodents and insects. Retain all receipts of pest control service.\*\*
