Dear Honorable Mayor and City Council of the City of Anaheim:

This letter is incorporated into the Claim Against the City of Anaheim that is filed herewith.

On October 2, 2009, I was unjustly attacked and brutalized by two Anaheim police officers acting under a color of authority. At approximately 12:30 a.m. on the above referenced date, officers Richard Olmedo and Edward Stancavage were driving a marked patrol unit through the Golden Skies Mobile Home Park where I maintain a residence. As I recognized these officers from a previous occasion when they assisted me in removing a trespasser from my property, I waived and said hello.

I observed the vehicle's speed increase as the vehicle approached me head on. Officer Olmedo forcefully flung the car door open into my body. He jumped out of the vehicle, grabbed my arm and twisted it behind me. This went on for approximately ten minutes until the officers placed me face first to the ground. I did not resist, nor was I combative. While I was lying face down on the asphalt, Officer Stancavage approached, pushed my face into the asphalt and kicked me four times. The officers were yelling conflicting commands at me so that if I obeyed one, I would disobey the other; another ploy to provide them with a reason to further brutalize me.

I suffered multiple physical injuries which included a scrape to my forehead and pain in my arms. In addition to the physical injuries, I suffered emotional trauma and mental duress. I now suffer from an overwhelming anxiety and fear of being physically attacked. Further, since the incident I suffer from an inability to sleep which is caused by the mental anguish of reliving the event in my mind.

The officers alleged that I was under the influence of methamphetamine. This was a ruse designed to provide them with an excuse to carry out their plan of retaliatory abuse against me. I have been an outspoken proponent for the equal administration of justice within the city of Anaheim and this is the reason these officers unjustly brutalized me. I was not, nor did I appear to be, under the influence of methamphetamine. These officers did not have probable cause to believe that I was under the influence of methamphetamine. Refer to the drug test results attached hereto as Exhibit "A" and incorporated by reference.

The Monday prior to this incident I called for police to assist me in removing a trespasser from my property. The responding officer was rude and refused to assist me. Rather, he made repeated references to my attendance at Anaheim City Council meetings whereat I addressed issues related to the Anaheim Police Department. This incident, as well as numerous others, are memorialized in the documents attached hereto as Exhibit "B" and incorporated by reference. This information is also available for viewing at the following websites: whiteroseanaheim.com and anaheiminjustice.com.

Officers Olmedo and Stancavage wrote and filed a police report documenting their version of this incident. I have reviewed this report and have exposed eighty-two (82) false statements these officers made therein. An itemization of these false statements is attached hereto as Exhibit "C" and incorporated by reference.

I have consulted with legal counsel experienced in cases of this nature. Counsel has advised me that my case has merit and that I should pursue a civil action for damages. Further, I possess substantial evidence to support my claims against the City of Anaheim and to establish a pattern of abuse against me by officers of the Anaheim Police Department.

It is my desire to resolve this matter informally, thus obviating the need for costly and protracted litigation. I am making a claim against the City of Anaheim for the sum of \$85,000 to compensate me for the damages I suffered and continue to suffer at the hands of these officers of the Anaheim Police Department.

Your prompt attention to this matter is greatly appreciated.

***POLICE REPORT 1st READING
FALSE STATEMENT #1 THROUGH #14***

James Robert Reade. 100 W Midway Drive.

The following police report can be viewed at my website whiteroseanaheim.com.

On 10/02/09 at 0025 hours, Officer Stancavage and I were patrolling a mobile home park at 100 W. Midway Drive in our marked black and white police vehicle. We remembered a previous call, which we handled on 9/27/09 (G0#09-142451) involving a subject (Enrique Contreras - 08/03/87) who had several outstanding warrants. ~ FALSE STATEMENT #1 ~ We could not recall subject Enrique Contreras' name at this time; ~ FALSE STATEMENT #2 ~ however, we remembered his description (m/H 5'7" 160 lbs) and his involvement with mobile home #124.

On 09/27/09 at 0242 hours, officer Stancavage and I (officer Olmedo) had received a call from mobile home unit #124 (RP/Reade), who stated how S/Contreras was at his home causing a disturbance and was possibly under the influence of methamphetamine. ~ FALSE STATEMENT #3 ~ R/P Reade described S/Contreras and our communication center determined he had several outstanding warrants. We contacted R/P Reade near mobile home #124 on 09/27/09. He stated how S/ Contreras is homeless and was loitering on his property, prior to our arrival.

He further explained how S/Contreras routinely loiters at this mobile home park and likes to sleep in yards of un-occupied mobile homes. We conducted a search for the mobile home park and were unable to located S/Contreras.

On 10/02/09 at approximately 0025 hours, we drove through the mobile home park and attempted to identify any un-occupied mobile homes. ~ FALSE STATEMENT #4 ~ We decided to respond to mobile home #124 in an attempt to contact R/P Reade and obtain S/Contreras' name and or any additional information about his last known activity. ~ FALSE STATEMENT #5, #6, #7 & #8 ~ While driving past several mobile homes west of #124 we saw a male white subject (S/Reade) loitering near the middle of the road. ~ FALSE STATEMENT #9 & 10 ~ The area was not lit ~ FALSE STATEMENT #11 ~ and clear from any other subjects. S/Reade appeared to see our marked police vehicle and immediately approached our vehicle at a fast walk. ~ FALSE STATEMENT #12 & 13 ~ We were unable to recognize S/Reade, as the reporting party, who we had contacted on 09/27/09, at this point. ~ FALSE STATEMENT #14 ~

**POLICE REPORT 2nd READING
FALSE STATEMENT #15 THROUGH #43**

James Robert Reade. 100 W Midway Drive.

The following police report can be viewed at my website whiteroseanaheim.com.

S/Reade arrived near the front of our marked police vehicle and displayed a hyperactive/ excited behavior. I saw him sweating profusely while he flailed his arms from side to side. Based on S/Reade's immediate appearance and behavior we believed he was possibly under the influence of a CNS stimulant. Officer Stancavage stopped our police vehicle near the center of the street (facing westbound with our headlights on). ~ FALSE STATEMENT #15, #16, #17, #18, #19, #20, #21 & #22 ~

S/Reade approached the front passenger door of our vehicle, at a fast pace where I was seated with my window rolled down. S/Reade was now about two feet away from my open front passenger window. I feared S/Reade was under the influence of a dangerous - controlled substance and was in a position to injure us if allowed to arrive at my open window. I yelled out in a loud and clear voice, "Stop, get back step away from my door", as I attempted to exit my door (front passenger door). ~ FALSE STATEMENT #23, #24, #25, #26, #27, #28 & #29 ~

S/Reade ignored my clear instructions to back away from my door and was now standing - within inches of my open window. I yelled out again, "Back away from my door", as I pushed my door open in order to exit our vehicle for my safety. Due to S/Reade's close - proximity to my door and failure to back away, I struck the front area of his upper torso with my door. ~ FALSE STATEMENT #30, #31, #32, #33 & #34 ~

S/Reade took several steps back and clenched his fists down by his waistband, while he yelled out, "What the _____ (expletive) is your problem". I immediately instructed - S/Reade to stand in front of my police vehicle in a calm voice in an attempt to calm him - down. S/Reade remained verbally abusive; however, he appeared to relax his flexed - muscles and walked toward the front of our police vehicle. ~ FALSE STATEMENT #35, #36, #37, #38, #39, #40, #41, #42, & #43.

After a thorough review of the police report I have identified 18 additional false statements written by the two policemen who assaulted me and falsely charge me.

**POLICE REPORT 3rd READING
FALSE STATEMENT #44 THROUGH #61**

James Robert Reade. 100 W Midway Drive.

The following police report can be viewed at my website whiteroseanaheim.com.

Due to his aggressive behavior and un-provoked actions I decided to conduct a cursory search of his person for weapons. S/Reade was wearing a loose blue shirt over the waistband area of a pair of blue sweatpants. S/Reade remained upset, as he clenched both - of his hands around the top bar of our push bumper. I told S/Reade to relax again and

explained how I was going to search him for weapons. I attempted to control his left hand with my left hand by holding his wrist. S/Reade immediately twisted his left hand and grabbed the top of my left hand. He began to squeeze my left hand with his left hand. I called out, "let go of my hand", as officer Stancavage was now in position to control his right arm (right arm bar). ~ FALSE STATEMENT #44, #45, #46, #47 & #48 ~

I was able to free my left hand and re-positioned my left hand on S/Reade's left wrist. I instructed S/Reade to relax and get down on his knees. S/Reade refused to kneel down and yelled at us to leave him, "the _____ expletive alone". S/Reade attempted to pull his left arm away from me, while he twisted his body towards me. Officer Stancavage and I feared S/Reade was preparing to injure us by fighting with us. S/Reade's stature is of a large frame person (6'3" and 190 lbs) and combined with a CNS stimulant influence we feared he had the ability to seriously injure us (officers) if not immediately controlled. It is our experience how subjects under the CNS stimulant possess great strength and high tolerance to pain. ~ FALSE STATEMENTS #49, #50, #51, #52, #53 & #54

Officer Stancavage and I tackled S/Reade to the ground onto his stomach. S/Reade attempted to roll onto his left side, while we maintained control of his arms. Officer Stancavage and I used our body weight to prevent S/Reade from continuing to resist and handcuffed him, without any additional force. ~ FALSE STATEMENTS #55, #56, #57 & #58 ~

Officer Stancavage escorted S/Reade to his feet and performed a "Drug Influence Evaluation" (refer to his supplemental report). ~ FALSE STATEMENT #59 ~

We observed a minor abrasion on S/Reade's left forehead area. We were unable to determine how this injury occurred. He did not complain about any injuries and/or pain. ~ FALSE STATEMENT #60 & #61 ~

POLICE REPORT 4th READING
FALSE STATEMENT #62 THROUGH #82

James Robert Reade, 100 W Midway Drive.
The following police report can be viewed at my website whiteroseanaheim.com.

On the above listed date and time, I (Stancavage) assisted my partner Officer Olmedo with a call we were on. See officer Olmedo's report #09-144944 for further details.

James Reade was already detained and under arrest. He was in handcuffs so I advised him of his Miranda rights from the APD 432 form. He said he understood his rights by answering, "Yes" to all of the questions. I told him I wanted to evaluate him for possibly being under the influence of narcotics. He refused to answer most of my questions regarding the investigation. But I was able to notice the following signs and symptoms. ~ FALSE STATEMENT #62 & #63, #64 & #65 ~

While speaking to James Reade I noticed his pupils were extremely dilated beyond what a normal range would be (normal 3.0 – 6.5 mm). James Reade pupils were 7.0 mm in dark lighting conditions. As I flashed some light on them with my flashlight I could see that his pupils were very slow to react to the light with little or no change. As I spoke to James Reade I could see that he had a thick off white yellow coating on his tongue. His lips were also very dry and had extreme dryness and cracking around the edges. James

Reade was very nervous and fidgety. He could not stop talking and stand still. I asked him several times to just stop moving and stop talking. I wanted to attempt to get a possible Romberg reading from him, however he was only able to stop for about five-seconds. James Reade was also sweating for the cool weather outside. His skin was hot and sweaty to the touch. On several occasions James Reade was talking so fast I could not understand what he was trying to say. ~ FALSE STATEMENT #66, #67, #68, #69, #70, #71, #72, #73, #74, #75, #76 & #77~

Based on my observations I believed James Reade was possibly under the influence of a controlled substance. I attempted to perform an under the influence evaluation on him. See attached under the influence evaluation for details. While conducting the evaluation I checked James Reade pulse on three separate occasions within a fifteen minute period. All of James Reade pulses were around 108 BPM. James Reade was extremely non-cooperative and argumentative during the process.
~ FALSE STATEMENT #78, #79 & 80 ~

While attempting to complete the medical questionnaire near the end of my evaluation James Reade stated he wanted an attorney. I did not ask him any questions regarding the interview, however I did continue to observe his signs and symptoms.
~ FALSE STATEMENT #81 ~

Based on my training, experience and evaluation of James Reade, we charged him for 1550 H&S, under the influence of a controlled substance, CNS stimulant. ~ F S # 82 ~
