





Our elected leaders need to be reminded of what hardworking Californians already know: these devastating cuts to public education are undermining our state's future.

According to a recent poll from the Public Policy Institute of California, most Californians believe there is not enough state funding going to public schools, and a strong majority single out K-12 education as the area they most want to protect from spending cuts.

Great leaders promote the success of all students by developing a vision of learning, providing a positive school culture and a safe and effective learning environment. Professional learning opportunities such as this conference are helping us lead our schools toward the same goal: success.

The following strands describe the major areas of focus in the conference program. Use the icons to find sessions of a specific strand in the listings of clinics, critical issues and workshops.

Budget and Finance [BF]

The budget and finance strand includes a broad spectrum of learning opportunities about sound fiscal management, budget oversight, cost-cutting strategies and turning assets into revenue. Topics include: values based budgeting; aligning budgets with strategic planning; district unification; issues surrounding basic aid districts; health care costs; creative and innovative strategies in budgeting; establishing foundations; state, federal and local budget issues; funding special education; funding research and litigation issues; increasing output with less money; value of class-size reduction in elementary districts; re-engineering the budget process; outsourcing; energy efficiency to save money; budgeting for both new and experienced board members.

Community, Communication and Collaboration $_{\tt [CC]}$

This strand includes sessions on how board members can enhance the image of public schools by educating and engaging parents, community members, local government and media, and establishing partnerships with various organizations and entities. Topics include: communicating with the community on budget, parcel taxes and bonds; partnerships with civic/service organizations, foundations, city, county and schools; resource sharing; enhancing the perception of public schools; student well-being where safety nets are gone; higher education partnerships; establishing foundations.

Emerging Trends in Education [ET]

This strand aims to address the multiplicity of emerging issues that impact the work that governance teams do. Topics include: accountability; charter schools; reauthorization of the Elementary and Secondary Education Act; classic litigation issues that affect districts; board composition as a reflection of the community; at-large and by trustee elections and demographic shifts; current research.

Leadership through Governance [LG]

This strand will equip board members with the tools and strategies to become effective agents of change and includes development of the board member as political and civic leader; the role of board member as advocate; board member as builder of civic capacity in their communities; the board member as community organizer; understanding the role of the individual trustee as part of the board; the board as a proactive governing body; district direction setting; aligning goals with student achievement; superintendent search process; local and statewide advocacy; ethical leadership.

Student Achievement [SA]

Student learning is at the heart of all education leadership. School boards govern to maximize student achievement. Topics in this strand include those on student achievement and closing the achievement gap: best practices from top performing schools in the state; high performing schools that are high ELL and low socio-economic; model programs that close the achievement gap for African American, American Indian, Asian/Pacific Islander, Hispanic students and children served by county offices of education; developing a district plan for the arts; maintaining Career and Technical Education during tough economic times; special education and demographic trends; autism; character education; algebra; A-G as a default curriculum; lessons from high performing charter schools; understanding the ways in which students process information; developing systems thinking/strategic thinking in students; the changing world and its impact on curriculum and teacher preparation; re-engineered education for 21st century skill sets; using data to evaluate results.

Technology [T]

The technology strand this year encompasses both the use of technology for district use and communication as well as in relation to student learning. Topics include: the use of language learning programs; technology for direct instruction; online learning and teaching; online courses as an alternative to AP classes; addressing the needs of 21st century students; technology's impact on children; technology to communicate internally.
