This office functions as the City Attorney for the City of Fullerton and the legal advisor to its Police Department and it is in that capacity I write. The California Public Records Act request you sent to the Fullerton Police Department dated November 14, 2016 has been sent to us for review and response.


In your request you seek several items. The first item you seek is the 911 call log from November 9, 2016 between 1201 hours to 0300 hours. The Fullerton Police Department maintains a Call For Service log in compliance with Government Code §6254(f)(2). It is available for inspection at the Fullerton Police Department during regular business hours.

The other items you seek such as the 911 tape/audio records from November 9, 2016 between 0100 hours to 0200 hours, the body worn camera footage from the officers who responded to the call which ultimately became Fullerton Police Department case number 16-74804, the field sobriety test results and the photographs pertaining to that same case will not be provided. All of those items are exempt from public disclosure pursuant to Government Code §6254(f) and 6255.
